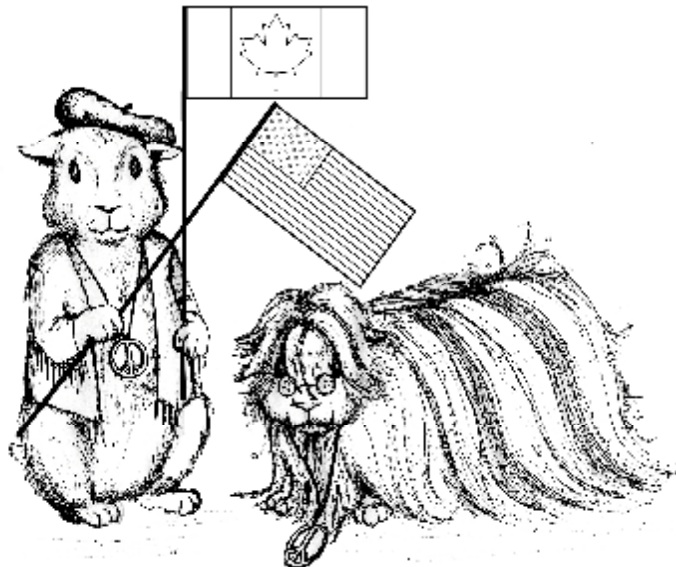

### NYSCF SHOW RULES:

Both shows are sanctioned by the American Rabbit Breeders Association and the American Cavy Breeders Association and will be governed by their latest show rules and standards. Filing of entry indicates acceptance of these rules. All official ARBA show rules will be in effect.

Judging will begin at 9:00 am sharp.

This is a leak-proof carrying case show.

**NYSCF reserves the right to substitute judges at any time.**

**A returned check fee of \$30.00 will be charged the first and second time a check is deposited.**

**All children must be supervised.**

**Any cavy showing signs of disease will be removed from the showroom and the entry fee will be forfeited. The show superintendent may remove any animal showing signs of illness from the showroom.**

**All cavies must be permanently earmarked. Judging will be done by private ear number. Please place number with adhesive tape on animals' ear.**

**Exhibitors are solely responsible for getting their cavies to the table when their breed/variety is called. Classes will be called a maximum of three times.**

**No camping at the show site.**

**The NYSCF will not be responsible in case of fire, theft or accident.**

### **Directions to the Show:**

**From East or West: Take the NYS Thruway (90) and get off at exit 46 (Henrietta/Rt.390). After going through the tollbooth, bear to the left and follow directions from the south below.**

**From the South: Come Off of Route 390 North – take exit 12, Lehigh Station Road/RT. 253. Make a right at the light off the exit ramp. At 1st light (Middle Road) turn left – go to end of Middle Road, turn right go about one mile – entrance to the Dome Arena is on the right. When entering the fairgrounds, the entrance to Minnett Hall is past the Dome on the right – follow signs. If you go to Route 15A (East Henrietta Road), you have gone too far.**
